### Waiver / Release of Liability

I understand that NH law states that each participant in the sport of skiing and snowboarding “accepts as a matter of law, the dangers inherent in the sport, and to that extent may not maintain an action against the operator for any injuries which result from such inherent risks, dangers, or hazards,” etc. See NH Statutes Section 225-A:24.

I further agree to assume all responsibility for risk of damage or injury that may occur to me as a participant in the 100K Vertical Challenge Event at Wildcat Mountain Ski Area on March 1, 2010\*. In consideration of being accepted as an entrant in this Event, I hereby, for myself, my heirs, executors and administrators release, discharge, and hold harmless Wildcat Mountain Ski Area Inc., the Make-a-Wish Foundation, any and all sponsors of the 100K Vertical Challenge Event, from all claims, damages, rights of action, present or future, whether the same be known, anticipated, or unanticipated, resulting from or arising out of, or incident to, my participation in this Event. I hereby certify that I am physically fit, and have sufficiently trained for participation in this event. I also grant use of my name and/or picture in any broadcast, photography or other account of this Event. I agree that the 100K Vertical Challenge Event is not a race and that I will abide by the Skier Responsibility Code, and ski or ride in control at all times:

1. Always stay in control, and be able to stop or avoid other people or objects.
2. People ahead of you have the right of way. It is your responsibility to avoid them.
3. You must not stop where you obstruct a trail or are not visible from above.
4. Whenever starting downhill or merging into a trail, look uphill and yield to others.
5. Always use devices to help prevent runaway equipment.
6. Observe all posted signs and warnings. Keep off closed trails and out of closed areas.
7. Prior to using any lift, you must have the knowledge and ability to load, ride and unload safely.
